2.1. The SRC endorses the Al-Nakba protests for Palestinian freedom and against apartheid Israel.

2.2. The SRC supports the upcoming Sydney Free Education Protest – Staff and Students United in solidarity with striking USYD staff

The paper was taken as read.

It was noted that SRC supports better education quality and staff conditions and that it is particularly important given enterprise bargaining by staff across multiple campuses this year. Therefore, the matter proves to be a critical aspect of the broader Sydney University activism beyond just UNSW campus.

2.4. The UNSW SRC seeks to remove the current Paddington Campus Representative for inadequate performance and lack of engagement

The Paddington Domestic Officer raised that whilst working with the Paddington Campus Representative, they have not attended meetings or made regular communications, making work difficult to progress. It was suggested that someone else could make better use of the position.

A vote was carried, with the majority in favor.

RESOLVED

2.5. The SRC will review their affiliation with the NUS via Arc, pending structural reform to accountability mechanisms within the NUS

The paper was taken as read.

Even though the allegations are still only being investigated at the point, it was noted that the seriousness of the matter necessitates an immediate response and reactions from member campuses such as UNSW.

More clarification and information will be sought from the NUS, for which the President will make available to the SRC as soon as available.

It was mentioned that in the previous meeting, the motion was passed to join AISA, however SRC has not joined AISA entirely, which is still pending clarity on financial pathways. The President raised that she will not be approving any financial release to AISA until transparency is met. The SRC finances are to be prioritised and protected until clear actions are disclosed by NUS.

RESOLVED

THAT the SRC will review their affiliation with the NUS via Arc, pending structural reform to accountability mechanisms within the NUS.

3. Matters for Discussion

3.1. The UNSW SRC is concerned about UNSW ADFA's decision to teach an Explosives Ordnance Course and calls on the Academic Board to reconsider endorsing this course The paper was taken as read.

Two major issues include the impacts on First Nations communities and the environment itself.

Further discussions:

- Whilst the course is associated with UNSW, the university should move away from such association.
- Tharunka noted that ADFA would offer the course initially to Australian Defence Force
 personnel, with potential in the future to be offer to UNSW students. It was raised that
 manufacturing and usage of explosives will also be taught rather than purely disposal.
 Concerns were raised if the course is to open to civilians.
- Greater concerns associated with ADFA running the course on Indigenous land.
- The issue should be continued to be discussed to monitor any future unfoldment of situations.
- The President noted that the matter can be flagged with the Academic Board.

The Environment Officer mentioned that there are a few university student contingents, where they are working with other universities.

Demands on view include:

- 1. First Nation Justice, no mining or fracking on Indigenous land.
- 2. Shut down the fossil fuel industry, no to Morrison's gas field discovery.
- 3. 100% publicly earned renewable energy now.
- 4. Support communities adjust transition to green jobs, funding for essential workers.
- 5. Restore the right to protest.

Everyone was welcome to attend the events.
