2 MATTERS FOR DECISION

2.1 Protest UNSW's Climate Crimes

The paper was taken as read.

For the motion:

- Climate change continues to stand as an important issue to students.
- Criticism was voiced towards the university's 'greenwashing' attempts.

There were no speakers against the motion.

RESOLUTION

THAT the SRC supports the 9th April 'Protest UNSW's Climate Crimes' Speak-out.

CARRIED

2.2 SimSchool Fee

The paper was taken as read.

For the motion:

- Students should not have to pay additional fees for their education/qualifications on top of existing university fees, especially in the face of the cost-of-living crisis.
- By voicing strong opposition towards this newly introduced fee, a good precedent can be set for students to stand against further fee introduction.

There were no speakers against the motion.

RESOLUTION

THAT the SRC endorses the 'Reimburse mandatory \$80 SimSchool fee for student teachers' petition.

2.3 Oppose Rise in Global Militarism

The paper was taken as read.

- An amendment was made to the key points of the resolution
 - Addition of: The SRC condemns Right Wing Pro War events on campus. University campuses should not be a place to celebrate militarism and death.

For the motion:

- Promotion of militarism on campus can make students feel unsafe
- · Criticism was voiced towards 'silent' stances on militarism





There were no speakers against the motion.

RESOLUTION

THAT the SRC opposes the global rise in militarism.

CARRIED

2.4 Labor Inaction on Cost-of-Living Crisis

The paper was taken as read.

For the motion:

- The Labor party was criticized for not taking meaningful action to address the cost-of-living crisis and its prioritization of major companies over the working class.
- Support was voiced for measures such as rent caps, building more affordable housing and an increase in welfare payments.

Against the motion:

The Labor party has provided a progressive budget in comparison to the past 15 years which
has supported the working class, enabling, for example, fully funded public education. The
Council was encouraged to consider the Opposition's budget which would include cuts to
Medicare and essential services.

RESOLUTION

THAT the SRC condemns Labor's inaction on the cost of living crisis.

CARRIED

2.5 Standardised Assessment Timing

The paper was taken as read.

RESOLUTION

THAT the SRC will advocate for the introduction of standardised assessment due times across all courses.

CARRIED

2.6 Caps on Final Assessment Weighting

The paper was taken as read.

For the motion:

• Capping final assessment weighting to 40% and introducing smaller tests throughout the term would provide a low-cost solution that would benefit students' wellbeing and mental health.

There were no speakers against the motion.

RESOLUTION

THAT the SRC will advocate for the introduction of a 40% cap on final examination weighting across all courses.

CARRIED

2.7 Extension System on Assignments

The paper was taken as read.





For the motion:

 A standardised extension system would reduce pressure and mental load on students to prepare documentation for an extension application during an already stressful period.

There were no speakers against the motion.

RESOLUTION

THAT the SRC pushes the university to adopt a universal short extension system.

CARRIED

2.8 Oppose Islamophobia and anti-Semitism on Campus

The paper was taken as read.

- An amendment was made to the key points of the resolution
 - Removal of 'The SRC opposes the presence on campus of any individual who spreads hateful rhetoric or seeks to justify violent acts and war crimes.'

RESOLUTION

THAT the SRC opposes the rise of Islamophobia and anti-Semitism on our campus and communities.

CARRIED

2.9 KU Leuven

The paper was taken as read.

For the motion:

- Lack of disciplinary action towards a guilty conviction sets a dangerous precedent for future cases and further discourages victims to speak up.
- Unanimous concern was raised for student safety as UNSW is a part of an exchange program
 with KU Leuven.

There were no speakers against the motion.

RESOLUTION

THAT the UNSW SRC supports demands for KU Leuven to take disciplinary action against medical student found guilty for rape.

2.10 Open Letter for Free Speech in the US

• Freedom of speech is an international issue, so it is crucial that the SRC supports this motion to set a standard and make their stance clear.
