TERMS & CONDITIONS

By purchasing a ticket to this Roundhouse Event, You confirm that You understand, agree to, and accept all terms and conditions contained here.

1) GENERAL

- a) You warrant that you are over the age of 18, and are legally entitled to accept these terms and conditions, and create legally binding obligations for any liability You may incur.
- b) Arc shall not be responsible for or deemed to be in default because of delays in or failure to provide the Event due to causes beyond its reasonable control e.g. strikes, riots, fires, floods, explosions, natural disasters, serious accidents, acts of government, acts of God, failure of transportation, epidemics, or quarantine restrictions.
- c) Arc may engage third party service providers to deliver the Event, including venues, ground transport operators, caterers, activity organisers, and other goods and services connected with the Event. You understand that Arc does not own, operate or control any of these service providers, accepts no liability for the provision of such services, and makes no warranty as to their quality and standard.
- d) Any information provided by Arc about the Event is given in good faith and is based on information available at the time. Where information is provided by a third party, Arc makes no warranty as to its accuracy.
- e) You have a duty to exercise good judgment and act in a responsible manner while attending the Event. You are expected to follow all rules and regulations, safety instructions and reasonable directions given by Arc staff, volunteers, authorised representatives and any third party service providers which may be involved in delivering the Event.

Accordingly, Arc is under no obligation to refund any part of the costs paid by You if You are not satisfied with any aspect of the Event irrespective of the reason.
